#### Professionalism, Achievement, Pride

I have never been more proud to be a member of the 111th Fighter Wing. Pride is defined as "satisfaction with achievement." Not individual pride, but a collective pride in what we achieved together. I realize we have accomplished much during the past four years, but I consider our recent Afghanistan deployment the highlight of my time here with the 103rd Fighter Squadron. During this deployment I learned to truly appreciate our Airmen's professionalism, what can be achieved as a result of that professionalism as well as discovering a new source of pride.

Unlike our Iraq deployment where we worked autonomously from other flying units, Afghanistan allowed us the opportunity to work closely with the many active duty and Guard squadrons that comprised the 455 AEW. One of my responsibilities as a Top-3 duty stander was briefing the Wing Commander, Brig Gen Holmes, on our operational performance, while Lt Col Mike Regan briefed our maintenance status. Every unit assigned to the 455 AEW had to do the same, and it didn't take me long to realize that, as the song goes: "One of these things is not like the other." knew we were good, but I didn't know how good. I've always respected our maintainers for their level of professionalism and what they achieve on a daily basis, but it wasn't until I saw our performance quantified and directly compared to other units that I realized there is indeed a difference. I have to confess that I had taken much for granted.

Another unique feature of this deployment was that we integrated pilots from five different units into one. Working with these pilots on a daily basis provided a rare opportunity to see how we compared as far as leadership



styles, tactics and operating procedures. Again, it became quite obvious that our leadership's level of professionalism was both respected and appreciated by the augmenting pilots.

How many times have you been asked "Where were you on 9-11?" September 11th, 2001 is the defining moment of our generation, in the same way the assassination of President John F. Kennedy was

a defining moment for the 60's. There's little doubt that anyone who was alive and awake on 9-11 remembers very specifically what they where doing that morning. difference. The 111th Fighter Wing is full of Airmen like Staff Sgt. Nicholas Fanelli and Senior Airman Dan McLeer who both joined post 9/11/2001. I'm proud to serve with these young Airmen who patriotically responded to that day's event with action.

It's quite remarkable what our all volunteer Wing continues to achieve as a result of our professionalism, personal commitment and patriotism. To me professionalism is not the job you do, it's how you do the job, and is the foundation for great achievements. What the 111th Fighter Wing achieved in Afghanistan is indeed a great source of pride, a source of pride I promise to never again take for granted.

#### Wing participates in Navy Integrated Training Exercise

Members of the 111th FW participated in a Navy integrated training exercise (ITE) at NAS Joint Reserve Base Willow Grove Oct. 9. Training teams comprised of members from a variety of Navy and Air National Guard sections were tested on their ability to respond to an on-base emergency based on their section-specific emergency response plans. From varied areas of expertise, they had to assess the situation, develop a course of action, perform operational risk management and engage the target.

Members from the Navy Command Staff, Navy Security, ANG Security Forces, contract security, Fire & Emergency Services, Navy Health Clinic, Emergency Management, Public Affairs, Fleet and Family Readiness, and Religious Ministry Support were evaluated on how they reacted to a scenariodriven exercise. The exercise evaluated security procedures, airfield intrusion, securing the runway after an attack, casualty care, incident command operations and consequence management. In this example, they were gauged on how they would react and communicate with one another should intruders come on base, attack the airfield and detonate an IED blowing up an aircraft and injuring bystanders.

Security ran through a scenario to apply lethal force, detain the intruders and secure the runway to prevent further loss

of life and property. The exercise gave medical personnel the opportunity to treat casualties. All training teams relayed exercise inputs from the field through the emergency operations center (EOC). Representatives at the EOC coordinated with other functional areas and passed the information back out to their counterparts. Weapons of mass destruction personnel and firefighters conducted live training on the flight line. A multimedia team comprised of a photographer and a


Every quarter, the Navy holds a training drill. This is the fourth such exercise held jointly with the 111th FW.

#### A-10s ready as Hawgsmoke 2008 begins By Master Sgt. Bill Huntington 442nd Fighter Wing Public Affairs

Two A-10 Thunderbolt IIs broke through the overcast skies of central Kansas Oct. 15 and crossed over the center point of the Salina Airport's north-south runway officially kicking off Hawgsmoke 2008, the Air Force's biennial A-10 bombing and tactical gunnery competition.

The moment also marked the end of two years of exhaustive preparation for the Airmen in the 442nd Fighter Wing's 303rd Fighter Squadron, the event's host and an Air Force Reserve Command unit from Whiteman Air Force Base, Mo.

The 303rd FS Airmen earned the right to host the contest by winning Hawgsmoke 2006, held at Davis-Monthan AFB, Ariz., that year, which pitted the 303rd's pilots against pilots from 16 other Air National Guard, Air Force and Air Force Reserve A-10 units from around the world.

Hawgsmoke tests A-10 pilots in flight leadership, target acquisition, weapons delivery and support and the amount of preparation and coordination to host the event is daunting.

"There is a lot more that goes into Hawgsmoke than the general public and most of the participants realize," said Maj. Les Bradfield, 442nd Operations Support Flight. "It's much more than just coordinating between an airport and a range."

One late wrinkle in the preparation was the announcement by Air Force officials of a time-compliance technical order, or TCTO, that required immediate inspection and repair of wing cracks approximately 130 A-10s throughout the Air Force. Maintainers in the 442nd FW were required to inspect 11 of the unit's 27 A-10s.

The order caused units to re-evaluate their ability to participate and caused some to cancel. Other wing's with available A-10s, including the 442nd, stepped forward to provide aircraft for those who

couldn't use their own jets.

Even though there were enough teams and aircraft to compete, the TCTO hampered some units in their ability to bring maintenance personnel to support Hawgsmoke 2008 as they worked at their home stations to inspect and repair A-10s. Still, the maintainers were able to meet the challenge.

"Everybody is [affected]," said Chief Master Sgt. Greg Wetzel, 442nd Maintenance Squadron. "Getting the rest of their fleet up to speed became a higher priority [but] we have enough people here to take care of everything. It's not really an issue."

Having the first two jets cross the airfield's center point is a source of excitement and relief for Whiteman's Citizen Airmen. It means that while the preparation has paid off and the competition is underway, there is still work to do as more aircraft arrive.

"We've only just begun," Major Bradfield said. "Having the 'iron' on the ground means the all of the work of the last two years, not only for the local community but for our own people, is starting to pay off."

## Community laces up to support VFW Freedom Steps 5K Walk/Run

Runners and walkers alike braved the rain to participate in the first annual Willow Grove Veterans of Foreign Wars (VFW) Post# 3612 Freedom Steps 5K Walk/Run held Sept. 28 at Mason's Mill Park in Huntingdon Valley, Pa.

"The purpose of today's event is to recognize the troops and the sacrifices they make every day," said Ralph Storti, Pass Commander of VFW Post #3612. "People back home appreciate what they're doing and they won't be forgotten."

"We started working on this event back in June," said Heather Salazar, event coordinator. "Upper Moreland Township Parks and Recreation helped us set everything up. Local businesses sponsored the event and were more than willing to help. The local VFW received a state grant to fund this event."

The grant came through the office of State Rep. Thomas Murt (R-Montgomery/ Philadelphia). Since 1990, Murt has served in the Army Reserve and is a staff sergeant assigned to the 656th Area Support Group. He is a member of the Veterans Affairs and Emergency Preparedness, Education, and Children and Youth committees. In 2003, he was called to active duty and served in Iraq with the Army's elite 4th Infantry Division.

"The troops do so much for us and we need to give back to them," Salazar added. "We need to show our support to those overseas defending our freedom."

Recruiters from the Army and Air National Guard were onsite to talk to the general public and provide information on the benefits of joining the Guard.

"Events like this are a way to get the word out about the Guard," said Sergeant 1st Class Lisa Mancini, recruiter with the Army National Guard. "We share opportunities with the community, youth and prior service members looking

for another way to serve."

"People thank us for serving, they're interested in what we do and the future of

# Passing fitness score required for promotion, reenlistment, AGR service

You might have thought your fitness score was only required to check your name off the overdue list or to fill in a block on your Performance Report – this is no longer true.

Effective immediately, a passing fitness score of 75 or above is required for promotion, reenlistment, and entry into an AGR or Statutory Tour program. Remember, it is our job to be Fit to Fight!

The following is a summary of the NGB/A1 policy memo created to supplement the ANGIs that govern these actions until a rewrite is accomplished. If you would like to see the actual message, please ask your unit leadership or anyone in the Mission Support Flight.

**Promotion:** An enlisted member is not eligible for promotion if he/she fails to score a 75 or higher on the Fitness Test.

Reenlistment: To be eligible to reenlist, an enlisted member must have scored a 75 or higher on the Fitness Test. Commanders may extend a member for a minimum of six months if they are not meeting the minimum score, but members that have already accumulated a total of 48 months on extensions to their current enlistment are not eligible. Commanders may request an exception to policy for members who have already been extended for the maximum of 48 months to allow the member to reenlist for one year. The exception request must have the Wing Commander and TAG's endorsement to be considered by NGB.

AGR/Statutory Tour Program: Any member in the Fitness Improvement Program is ineligible for entry into any type of AGR or Statutory Tour Program.

#### VA to Deploy Mobile Counseling Centers Across America

The first of a fleet of 50 new mobile counseling centers for the Department of Veterans Affairs (VA) Vet Center program was put into service Oct. 22 with the remainder scheduled to be activated over the next three months.

"Our widespread distribution of this fleet from coast to coast marks a new chapter in VA's innovation to reach rural and underserved veterans with high-quality readjustment counseling," said Secretary of Veterans Affairs Dr. James B. Peake.

Each vehicle will be assigned to one of VA's existing Vet Centers, enabling the center to improve access to counseling by bringing services closer to veterans.

The 38-foot motor coaches, which have spaces for confidential counseling, will carry Vet Center counselors and outreach workers to events and activities to reach veterans in broad geographic areas, supplementing VA's 232 current Vet Centers, which are scheduled to increase to 271 facilities by the end of 2009.

Vet Centers, operated by VA's Readjustment Counseling Service, provide non-medical readjustment counseling in easily accessible, consumer-oriented facilities, addressing the social and economic dimensions of post-war needs. This includes psychological counseling for traumatic military-related experiences and family counseling when needed for the veteran's readjustment.

The team leader at each Vet Center will develop an outreach plan for use of the vehicle within that region, not being limited to the traditional catchment area of a particular Vet Center.

These vehicles will be used to provide outreach and direct readjustment counseling at active-duty, reserve and National Guard activities, including post-deployment health reassessments for returning combat service members.

The vehicles will also be used to visit events typically staffed by local Vet Center staff, including homeless "stand downs," veteran community events, county fairs, and unit reunions at sites ranging from Native American reservations to colleges.

While most of their use will be in Vet Centers' delivery of readjustment counseling services, the local manager may arrange with VA hospitals or clinics in the region to provide occasional support for health promotion activities such as health screenings.

The normal counseling layout can be converted to support emergency medical missions, such as hurricanes and other natural disasters.

#### Six Weeks and Counting

Following the 111th's transition on Dec. 12 to the new operating systems for e-mail messaging and Microsoft Office, each user will be receiving a survey titled "ANG Exchange 2007 Project Feedback Survey," where every user will be given the chance to "grade" our performance on this project.

Survey statements can be answered "Strongly Agree," "Agree," "Undecided," "Disagree," or "Strongly Disagree." Anyone who answers "Undecided" or "Disagree" will be asked to add comments.

Survey statements will be as follows:

- 1. I was informed of a new email system.
- 2. I was informed that the MS Office 2007 was coming to replace MS Office 2003 on my desktop.
- 3. I was informed of computer and web-based training opportunities for MS Office 2007, including MS Outlook, MS Word, MS Excel, MS PowerPoint and MS Access.
  - 4. The MS Office 2007 product suite training was competent and relevant for my job.
  - 5. I was informed how my "old" e-mail could be accessed using MS Outlook 2007.

#### IT equipment requests

If you need a new piece of information technology equipment (ITE), the request must be routed through the 111th Communications Flight. This is true regardless of the value of the item. The reason is that there are minimum standards for ITE (processor speed, model, brand, capabilities, commercial or GSA purchase) that must be followed for government purchases of ITE. The person who interfaces with the Communications Flight is usually the unit Equipment Custodian, who will submit the request to the Plans & Resources Section, 111 CF/SCX, or (215) 443-1684/1685.

#### Tricare Reserve and Guard family benefit now permanent

Eligible families of activated National Guard and Reserve members will continue to save up to \$300 in annual deductibles now that a Tricare "demonstration" program is a permanent benefit.

Eligible family members of Guard and Reserve personnel activated for more than 30 days under federal orders in support of a contingency operation are made eligible for Tricare Standard and Tricare Extra, which have annual deductibles. While they may be eligible to enroll in Tricare Prime or Tricare Prime Remote for Active Duty Family Members, which have no deductibles, many may choose to stay with Tricare Standard or Extra.

Introduced as one of the first Tricare healthcare enhancements after Sept. 11, 2001, to assist the increasing number of National Guard and Reserve service members activated to support the war on terrorism, the benefit waiving annual deductibles has been a demonstration project for more than seven years.

"The demonstration has worked well and the benefit is not changing," said Army Maj. Gen. Elder Granger, deputy director of the Tricare Management Activity. "We simply want to make sure our Guard and Reserve families know this is a permanent benefit now that final federal regulation has been published."

Guard or Reserve families often meet annual deductibles under their commercial plans before they get activated. Waiving the Tricare Standard and Extra deductibles means eligible families will not have to pay additional deductibles under Tricare. The annual deductible for Standard and Extra is \$300 for families.

"National Guard and Reserve members and their families make huge sacrifices to protect our freedom. We don't want to see them sacrifice even more by paying deductibles twice in one year," General Granger said.

The published regulation also contains provisions that make it easier for Reserve and Guard members to continue to see their family physicians by potentially increasing the amount that can be paid to out-of-network health care providers.

Since eligibility for Tricare benefits is determined by the services, to ensure family members are eligible for the Tricare Reserve Family Benefit, activated Reserve and Guard members should visit their local military ID card-issuing facility and update their information in the Defense Enrollment Eligibility Reporting System.

#### McKinley approved to lead Guard Bureau

Air Force Lt. Gen. Craig R. McKinley was confirmed Oct. 2 as the 26th chief of the National Guard Bureau by the U.S. Senate.

He will also become the first four-star general in the nearly 372-year history of the National Guard.

The current director of the Air National Guard, McKinley was nominated by the President in September based on the recommendation of Secretary of Defense Robert Gates.

He succeeds Lt. Gen. H. Steven Blum, who was also confirmed Oct. 2 by the Senate to become the first National Guard deputy commander for the U.S. Northern Command. Blum has served as chief of the Guard Bureau since 2003.

As chief of the National Guard Bureau, McKinley will be the senior uniformed officer representing nearly 468,000 Citizen Soldiers and Airmen.

He will also serve as the principal advisor to the chairman of the Joint Chiefs of Staff on National Guard issues.

"I give all the credit for [this promotion] to the performance, friendships and relationships of [Blum]," said McKinley Sept. 22 at the National Guard Association of the United States (NGAUS) conference in Baltimore. "Lt. Gen. H. Steven Blum has been a fantastic chief of the National Guard Bureau."

Gates recommended McKinley for the upgraded four-star position in July

following the recommendations of the Commission on the Guard and Reserves and the fiscal year 2008 National Defense Authorization Act (NDAA).

The NDAA also established the Guard Bureau as a joint activity of the Department of Defense.

"General McKinley has earned this place in history," Gates said during the NGAUS conference. "I trust he will continue to lead the Guard to new heights."

A Florida National Guard member, McKinley has served as director of the 107,000-member Air National Guard since May 2006. Prior to that, he served as assistant deputy chief of staff for plans and programs at Air Force Headquarters. He is a command pilot with more than 34 years of military service.

McKinley was promoted to brigadier general in 1998, major general in 2001 and lieutenant general in 2006.
