## **Second Five Year Review**

The Naval Facilities Engineering Command Base Realignment and Closure Office (NAVFAC BRAC PMO) and the Air National Guard (ANG), in cooperation with the U.S. Environmental Protection Agency (EPA) and the Pennsylvania Department of Environmental Protection (PADEP), has begun the second five-year review of the remedies implemented at the former Naval Air Station Joint Reserve Base (NASJRB) Willow Grove, Pennsylvania. The purpose of a five-year review is to ensure that the selected remedies are effectively protecting public health and the environment. The five-year review process is mandated under the Comprehensive Environmental Response, Compensation and Liability Act (CERCLA) (also known as Superfund) for sites where the selected remedial action results in contaminants remaining above levels that allow for unlimited use and unrestricted exposure.

The ANG and NAVFAC BRAC PMO will conduct interviews, review reports, and assess site conditions to evaluate if the remedies remain protective of human health and the environment. Public participation is encouraged and welcomed. If you are interested in participating in the interview process, please notify the contact personnel listed below by January 31, 2018. The second five-year review is scheduled for completion in September 2018 and will focus on the following two sites where remedial actions have been implemented:
